# **KLAEF**2025

The Kuala Lumpur Art Book Fair (KLABF) is back for its fifth edition to honour the city's vibrant artist-run culture and selfpublishing scene. KLABF 2025 invites artists, designers, illustrators, writers, photographers, printmakers, independent publishers, alongside enthusiasts from Malaysia and beyond to gather under one roof for an exciting three-day celebration of the art book community.

This year's edition will feature an exciting roster of programmes, including talks, workshops, exhibitions, special showcases, and more - fostering a dynamic and inclusive space for confluence, conversation, and collaboration.

### GENERAL GUIDELINES.


- 1. This application is open to local and international exhibitors.
- 2. KLABF is a curated event. Submission of application does not guarantee participation in the Fair.
- 3. There will be a selection process to decide the final exhibitors. Confirmed exhibitors will be notified via email.
- 4. By submitting this form, applicants declare that they are able to produce a reasonable amount of printed matter in time for KLABF 2025 (refer to Selection Criteria).
- 5. Each applicant is required to include a brief on a minimum of TWO (2) publications (art books, magazines, zines, catalogues, photobooks, and other forms of self-publications).
- 6. Exhibitors are allowed to share booths, up to a maximum of TWO (2) exhibitors per booth.
- 7. For booth-sharing exhibitors, only ONE (1) application form is required.
- 8. Manpower must be arranged and provided at the Exhibitors' own cost.
- 9. Exhibitors are required to comply with the assigned setup/teardown schedule to ensure the Fair proceeds smoothly.
- Booth selections are subject to availability. Only a limited number of Showcase Booths (table with wall) will be allocated.

# SELECTION CRITERIA.

- 1. KLABF will priortize applications by those who (a.) have past experience in producing publications, and/or (b.) are actively publishing new works or experimenting new approaches/ methods with their practices.
- 2. Confirmed exhibitors are expected to produce at least TWO (2) publication works for sale during the event, such as zines, art books, catalogues, photobooks, and other forms of self-publications or independently-produced printed works. These publications may then be supplemented by other items for sale such as T-shirts, postcards and stickers.
- 3. Exhibitors will be selected based on information provided in the application — including images, texts and websites. In order to ensure a smooth selection process, please provide the most up-to-date and accurate information on your project(s) and portfolio. All links should be working, with full viewing access to its contents.
- 4. Exhibitors based outside of Malaysia are welcome to apply for KLABF 2025. Travel arrangements and manpower are to be arranged at the exhibitor's own cost.
